## FRANCIS MARION HOTEL, CHARLESTON, SC MONDAY, JUNE 16, 2003 1:00 PM

## WELCOME AND INTRODUCTIONS

Ron Simpson called the meeting to order at 1:02 PM. He welcomed everyone to Charleston and the Full committee meeting. He then asked everyone in turn to introduce him or herself. Alan Lowe circulated a meeting sign in sheet and asked all attendees to indicate their presence. He also circulated the committee roster for people to make corrections. Seventy-three committee members attended.

## SECRETARY'S REPORT

Blake Lloyd announced that the minutes from the last Main Committee meeting had been sent out. A minor correction was necessary where results reported for Toronto where in fact those for Portland. With this correction recognized, a motion was made and passed to accept the minutes. Based on the minutes mailing, Blake reported the following:

## EXECUTIVE COMMITTEE REPORT

Blake Lloyd reported that 18 members were in attendance at the Executive Committee meeting. The meeting started at 6PM Sunday evening and adjourned at 7:30PM and dealt with issues regarding falling attendance.

## 2002 TORONTO CONFERENCE REPORT

John Kay reported he was proud to be representing the Toronto planning committee and to provide to this committee the following final report for the 2002 conference. The threats of 9/11 and the continued digression within the pulp and paper industry did have some impact on ability to meet the planned number of participants. The reduced number of participants resulted in a significant shortfall of hotel room nights. This in turn resulted in a penalty imposed by the hotel. The Conference paid <sup>1</sup>/<sub>2</sub> of the penalty with the IAS and the Toronto Section the rest.

## TREASURER REPORT/CONFERENCE AUDITS

Dave Durocher reported that the both the Portland and Toronto conferences used the recommended 13-step process for audits and that the committee is satisfied with activities by both local conference committees. The Portland Conference made \$27K, 1/3rd of which was returned to the local IAS Chapter. These funds are being used to establish grant monies for two local Universities (Oregon State University and Portland State University) to further the Power Engineering disciplines. The Toronto conference lost money, driven primarily to payment of penalties from the hotel due to missing our room-night commitments.

## STANDING SUBCOMMITTEE REPORTS

#### **MEMBERSHIP**

Alan Lowe reported that our current committee membership is 123. Since the interim meeting in September we have had the following changes in membership: One (1) new member (Rob Dufton) and two (2) applications are pending (Tim Hoy, Universal Dynamics LTD, Gary Wetzel, S&C Electric Company).

At the interim meeting we had 42 members present, 48 members requested excused absences and 32 had unexcused absences.

#### MAILING LIST

John Kay reported that the list was updated with the corrections from the 2002 Interim meeting in Atlanta. The list now contains 1896 names. Members are encouraged to Email updates to John Kay.

#### PUBLICITY

Ron Meihofer reported the publicity release on the 2002 Conference held in Toronto, Canada on June 17-21 at the Sheraton Center was published in the *IEEE Industry Applications Magazine's* January/February 2003 issue. Announcements for the 2003 Conference to be held in Charleston, South Carolina on June 16-20, 2003 were sent to the various trade magazines.

#### PAPER AWARDS AND PUBLICATIONS

Laurie Cihlar reported on the Technical Paper Publication Status for 2002 Conference Papers:

#### **FELLOWS NOMINATIONS**

Clayton asked for help from the committee in identifying other people who are appropriate to be nominated as IEEE Fellows. Clayton is the Award Chair for the IEEE-IAS and as such has become aware of several other IEEE awards such as Distinguished Service, Young Members, and Harold Kaufman award for with members of this group are eligible. Clayton encouraged everyone to consider nominating appropriate members of our group. Clayton will be receiving his own Fellow award at this conference.

#### **PPIC AWARDS**

Russ Thrift indicated the 2003 Conference Meritorious Service Award is to be presented to Frank P. Newman and the Meritorious Engineering Award to Patrick J. Link at the banquet. Russ encouraged every individual on the committee to recognize them and also read the write-ups on each award winner. Nominations for next year's awards need to be made by the Interim meeting.

## Liaison Reports

#### PAPTEC (CPPA)

John Kay reported that during the last week of January of this year 11,726 participants from 25 countries experienced the various events of the 89th Annual PAPTAC technical sessions and the 45th edition of EXFOR, a product

exposition held in downtown Montreal, Quebec. PaperWeek, as it is called, provided the opportunity for high-quality exchange of science and technical information in the form of session meetings and presentations. There were 448 companies exhibiting at the EXFOR trade show exhibition held at the Palais des Congrès. In addition, the Forest Products Association of Canada (FPAC) and the Pulp and Paper Products Council (PPPC) held a number of forums open to the public. These public forums attracted additional participation at PaperWeek International.

- Number of delegates registering for the technical sessions: 998
- Number of additional EXFOR trade show visitors: 5,123
- Number of EXFOR trade show booth personnel: 4,250
- Total participants at the PAPTAC Annual Meeting: 10,371
- Countries Represented: 25 countries.
- Additional forums attracted an additional: 1,355 people,
- For a total attendance of 11,726 people!

Plans are already under way for 90th Annual Meeting of PAPTAC and the 46th edition of EXFOR. PaperWeek International 2004 will be held in Montreal next January 26-29.

#### **IEEE/IAS**

Clayton Reid reported the IAS Conference would be held in September.

#### TAPPI

Burt Judson reported that the he TAPPI --- PCE&I Division will meet with the Pulping Division the week of Oct 26th in Chicago at the Hyatt – downtown and the 2004 Paper Summit is in Atlanta, May 3 - 5, 2004 at the GWCC (Ga World Convention Center) ---- the PCE&I will have a technical session that week as well. Then in 2005 the TAPPI --- PCE&I Div. hopes to join with our own IEEE PPIC in Jacksonville.

#### **IEEE - STANDARDS COORDINATING**

Jim Daily reported SCC 18 met on February 9 and 10 to provide voting instructions to the IEEE representatives on the NEC Code Making Panels.

One proposed change of interest to this Committee is that a proposal was accepted to limit non-shielded cable to 2400V. The proposal did receive more than the 2/3 Affirmative votes required for acceptance. Even though IEEE voted in support of the lower limitation, I expect that there will be some recommended exceptions for industrial facilities submitted during the Comment period. The main intent was to eliminate non-shielded cables over 2400 V from general commercial wiring since that is where most of the problems occur.

Another change that could impact your plants involves changes to Section 110.16, Flash Protection, that includes new requirements for the marking of switchboards, panelboards, industrial control panels, meter socket enclosures, and motor control centers. If this proposal survives the Comment stage, each of these types of equipment, which may require examination or maintenance while energized, would have to be marked with a label indicating the incident energy available, or the rating of needed protective clothing in calories per square centimeter.

A global proposal was submitted to change "grounding" to "bonding". This would change an "equipment grounding conductor" to an "equipment-bonding conductor". The proposal was accepted by one Panel and rejected or referred to the Technical Correlating Committee by all the other Panels. The Technical Correlating Committee took action that the proposal accepted by the one Panel be reported as Reject to correlate with all the other Panel actions.

The NEC Report on Proposals will be issued by NFPA in July. The ROP will contain every proposal that was submitted along with the Panel actions on each proposal. The deadline for submitting Comments to NFPA is October 31, 2003.

IEEE C95.6, Standard for Safety Levels With Respect to Human Exposure to Electromagnetic Fields, 0 to 3 kHz passed ballot, withstood three challenges to the IEEE Standards Board, and has been published. The Standard addresses only acute effects and includes a statement that there is insufficient scientific evidence to support the theory that exposure to EMF causes long term chronic effects such as cancer. While OSHA participated in the development of the Standard, I have not heard anything regarding OSHA adoption of the Standard.

## Introduction

Bruce Graves welcomed all present to the Charleston PDS Subcommittee Meeting. Each member and guest was asked to introduce themselves. Robert Adams assisted in recording the meeting miuntes.

A list of the PDS members was circulated for updating and attendance. Updates have been forwarded to Alan Lowe.

#### **General Business**

Solicitations and recommendations for Meritorious Service Award and Meritorious Engineering Awards were requested. None were received.

Executive Committee Meeting Minutes were reviewed and discussed. The interim meeting will be held in Atlanta on October 19-20 at the Westin Airport Hotel.

Thanks go to Robert Adams and Bucky Hammonds for grading papers for the 2003 conference. Thanks also go to Alex Wu and Chuck Mozina for assisting with lights during the 2003 conference.

Bruce Graves and Ron Simpson reviewed and discussed the importance of the paper sponsors to the success of our technical program. The sponsor is the key to getting the author's work to the technical program chairman. A copy of the 2003 Authors Guide will be distributed to all subcommittee members. Please refer to page 4 for the schedule of papers.

The list of proposed papers was reviewed and updated with changes and new paper topics were discussed and added. The updated list is included in these meeting minutes.

Time during the new papers discussions was limited and tutorials for the 2004 conference were not discussed. The PDS Subcommittee members should come to the interim meeting prepared to suggest tutorials for the 2004 conference.

Chuck Mozina updated us on the status of the Generator Grounding and the Generator Grounding Working Group Papers. He advised us that the working group papers presented at the IAS Conference will be presented at the 2003 PPIC Conference.

The PDS Subcommittee sponsored two tutorials for the 2003 conference, both of which were very successful. They were Generator Protection and Power Quality Monitoring. Attendance at both were good.

Digital Relay Testing and Commissioning was discussed again as well. Chuck Mozina advised that he had presented a paper on this subject and suggested it for the 2004 conference. The title of the paper is "Testing and Commissioning of Multifunction Digital Relays" which is a report prepared by the IEEE/IAS Working Group.

Cliff Normand asked that an item be added to the meeting agenda to include discussions regarding the proposed National Electrical Code change relating to shielded conductors above 2,400 volts. Tom Settlemyre, George Matto and John Cancelosi with Okonite joined our meeting to discuss this issue. Based on current standards and codes, applications at 2.4 kV and 4.16 kV do not require

shielding. With the proposed change the impact to the users of our group could be significant. The gentlemen from Okonite advised that they felt that shielding above 2.4 kV was not required, but pointed out that some static discharges could be noticed on 4.16 kV applications where the cable is unshielded and physically close to a "Ground Plane." These meeting minutes defer to the gentlemen from Okonite for further clarification on this subject. The PDS Subcommittee thanks Okonite for providing their input.

The subcommittee talked about NFPA 70 E and the new IEEE Standard 1584 that has been published regarding Electrical Safety. There is a great deal of interest in this subject in the PDS Subcommittee as well as in the TSSC Subcommittee. The TSSC subcommittee held a mini-tutorial as a part of the general conference technical session on Thursday of the 2003 Conference.
