Appendix A – Classification and Schedule of Papers

The criteria for paper classification are as follow:

Class A: Paper has a sponsor, a committed author, an abstract, and a rough draft in hand, ready for review.

- Class B: Paper has a sponsor, a committed author, and abstract in hand.
- Class C: Paper has a sponsor and a committed author.
- Class D: Paper has a sponsor and an identified author.
- Class E: Paper has a sponsor.

Sponsors should make sure that the sub-committee chairmen get a copy of the author's data sheets and a copy of the Abstract. Reviewers should check the official guide to make sure that their role is understood. It is the responsibility of the reviewer to check the paper's accuracy, not to be the editor. The guide is available on the website. It is important that the sponsor not only coordinates the reviews of the paper, but also checks the presentation itself to make sure it conforms to IEEE guidelines, especially in the area of avoiding any commercialism (including company logos on template except for title page). Since the presentations are all in PowerPoint, they can be easily sent from the author to the sponsor or placed on the Pulp and Paper FTP site. It is a requirement that all authors / presenters register for the Conference, even if it is for only one day. This is also true for New Product Presenters.





# Appendix B - Anti-Trust Policy

IEEE's policy prohibits any discussion which constitutes or implies an agreement or tacit understanding concerning:

  - The volunteer will review ALL the papers submitted through ScholarOne for the 2018 conference
  - There are typically 22-25 papers, of 6-10 pages length, excluding any papers that the volunteer authors or coauthors
- IEEE New policy for publication in the Magazine and the Transactions
  - As of January 2017 ALL conference papers will be published in their ScholarOne version in the conference record





- Should the paper be recommended for publication in one of the periodicals, the paper will receive a REVISE AND RESUBMIT decision from the conference Associate Editor
- IEEE will no longer accept verbatim copies for multiple entries (e.g. conference record and periodical)
- The specific wording is that a "substantive" change is made between the two documents
- In practice, this is essentially going to come down to including the conference paper as a reference for the periodical version, and addressing comments and questions raised at the presentation of the paper (and/or from the SholarOne reviewers earlier)
- IEEE SCC 18, External Representatives (ER) to NFPA and 2020 NEC cycle
  - IEEE ER to NFPA 70, Code Making Panel 8, Paul Myers, reached out to the committee chair, Greg Drewiske, and myself
  - Paul wants to encourage PPIC members to join SCC 18 and become an ER to NFPA 70. Currently, there are open positions for principle and alternates on different code making panels
  - It is too late now to join the 2020 NEC cycle, so this will be for the next NEC cycle, i.e. 2023 NEC
  - Paul also wants to encourage our members to provide their input on the 2020 NEC first draft report that will include all the public inputs submitted to the 18 code making panels of the NEC
