11) OLD BUSINESS

a) James A. Rooks Memorial Grant Fund Status – Dave Durocher

The IEEE IAS PPIC has access to two funds held by the IEEE Foundation in the name of our former member Jim Rooks. The "James A. Rooks Memorial Intern Fund" was first established in





2007 and this fund's scope is limited in that the committee can use these funds only to support student interns working at paper mills to reimburse their costs to attend the annual conference. The "James A. Rooks Memorial Grant Fund" was established in 2014, and this fund includes a scope that allows flexibility for our committee to reimburse conference attendance by student interns, young professionals or others as deemed appropriate to promote growth of conference attendance via support of students and young professionals. Individual donors were required to submit written agreement to move funds from the Intern account to the Grant account when the Grant account was first established. The plan moving forward is to deplete the Intern Fund to zero over the next several years, and promote new donations to the Grant Fund. **The current balance of the James A. Rooks Memorial Intern Fund is \$48,015. The current balance of the James A. Rooks Memorial Grant Fund is \$171,915**

- i) Question posed if Rooks funds could be used to offset streaming of conference to improve attendance of mill engineers. Dave indicates this could be done with these funds, if not cost prohibitive, and recordings do lend themselves to more people watching when able.
- b) Rooks Student Interns & Young Engineering Professionals Emily Held
 - i) Send young engineers or interns to Emily. Incentives are improved, and invitations are redone to remove dates.
 - ii) No target, take whoever we can get, encourage interns especially.
 - iii) Vendors are encouraged to use their connections to cast a wider net to get more applicants.
- c) <u>PPIC Emeritus Program Chris Heron</u>
 - i) John Kay covering for Chris: Emeritus program is active, and information is in the Operating guide, including requirements. Applications do not yet exist, but will be forthcoming.
- d) Long Range Planning Items Mark Zawadzki
 - i) Social Media Strategy has been touched upon in previous meetings, but needs to be at forefront of the committee
 - ii) ISA co-locate is no longer going to be pursued.
- e) <u>Operating Guide Update Mark Zawadzki</u>
 - i) Lots of updates, and posted on the website. Rotations were updated to odd/even years due to lack of 2020 conference.
 - ii) Standards committee and Emeritus program have been added to the operating guide.
 - iii) Version 17 is the active version, and is posted on the website. Version 18 is already underway.
- f) Paper Submittal and Copyright Process Ad-Hoc Committee Update Dave Durocher
 - Scholar-One is the system for publishing, not necessarily for conference record. Other committees, including Electrical Safety Workshop use a very clean system. Dave and Chris to meet with them to discuss using Forms Plus for review, and then submit to Scholar one for peer review and publishing.
- g) <u>Standards Study Group Update Mark Zawadzki</u>
 - i) Previously discussed in the meeting.
 - ii) NEMA MG-1 on Motors and Generators is available for free pdf download on nema.org
 - iii) John Malinowski presented the following standards information: Latest IEEE-841 is updated, with many changes, for NEMA motors. IEC motors standard is separate, and expect a ballot.





Pulp and Paper is not well represented. Recommended Practice 2455, Repair Standard for DC Motors will also be balloted soon, all are welcome to participate.

 iv) Daleep Mohala: encouraging all PPIC members to participate in work groups, or at least ballot. Pulp and paper is a unique industry and has a lot to contribute. Standard 7.2 for Maintenance will be balloting next year. Joining the standards group is an option for membership. You can participate all you want, must be a member to ballot.

12) NEW BUSINESS

- a) Considerations if 2022 Conference is Affected by Coronavirus Mark Zawadzki
 - a. The conference is moving forward to have the conference in person, and the committee will plan to meet the second week of January to look at the current situations and determine path forward.
 - b. Discussion with PCIC members Peter Baen and Robert Durham, and reviewed general discussion and feedback on the hybrid conference at PCIC. Event Mobie a useful app, whova less so. This discussion occurred in the Executive Committee Meeting.
 - c. Discussion on PPIC in person vs hybrid: Duncan indicates the recorded conference presentations may hit the target potential audience, but getting some discount cost does still bring in money. John M. indicates hybrid filmed drastically increases cost of conference, but decreases income. Filming and posting does not allow for live QA sessions, however there are some options to livestream PPIC due to only having one track. Keep the major selling point of networking at the conference at the forefront. Need to encourage potential new attendees that in person is preferred and the networking is one of the most important aspects of the conference. Absolutely cannot cancel and push out Niagara again, would move on to different locations if cannot do Niagara Falls in 2022.
 - d. Covid considerations vs Hybrid discussion is separate discussion, is hybrid the way to go in the future to liven the conference? IEEE may have some resources to support this discussion. General consensus we cannot predict the future.
 - e. Marketing is going to be critical in the future. "I learned it at PPIC" may be a good strategy, to look at getting testimonials from members and using them as a marketing strategy. Get in on the different sites. LinkedIn. Need to have content, and fresh content.
 - f. Create a social media/marketing ad-hoc committee. Contact Duncan Rhodes <u>duncanrhodes@ieee.org</u> if interested, to participate, and this group will present at June. If you have marketing experience, please reach out.
