Goal for Phase One is to determine whether we have title and revision correct, and assure we can access them, if necessary. Phase Two will be to determine whether their current revision is actually relevant to the standard.

Where possible, during the Phase One review, make a determination on whether the bibliographical reference is still relevant.

- Chris Abernathy noted the new 6.2 uses the term "aging effect assessment" without a definition of the term. A quick review determined the phrase also exists in 5.3 (line 27) and new para. 6.7.6b). We should determine whether the phrase should be adjusted or defined.

- John Kichofel noted in the new 6.3c) the term "support functions" isn't defined. This is the only place in the document the term is used. Should we change or accept it?
- New paragraph 6.4, no comments
