1. Call to Order

The meeting was called to order by Chair, Rebecca Steinman, at 2:08 pm EST.

2. Roll Call

Rebecca captured 5 members in attendance based on WebEx participant list. Full roll call was not formally held, since it was clear quorum was not met.

3. IEEE Patent and Copyright Policy Review, slides attached

Rebecca revied the required policies at a high level and directed participants to the attached slides for additional details.

4. Discuss 23-09 Meeting Minutes (online approval)

Due to a lack of quorum the 23-09 minutes could not be approved. Rebecca will post the minutes online and attempt to get a quorum vote for approval ahead of the January 2024 hybrid meeting.

- 5. Review Previous Action Items
 - i. <u>All</u>. Evaluate content of EPRI NP-1558 Rev 1 (3002018283), Activation Energy Use & Verification, activation energy may require changes to the standard. ALL team to consider the issues as we review the Annexes.
 - ii. **Rebecca**. Report on NPEC change in approach to titles for standards. Due: After AdCom 23-2 meeting minutes published.

Suresh confirmed NPEC desired action with respect to standard naming convention. Rebecca will prepare a PAR revision ahead of the January meeting, but the need by date for approval is when we go to balloting after the July meeting, so there is no rush for approval.

iii. <u>All</u>. Consider change title from "...Facilities" to "...Nuclear Facilities." ALL be prepared to discuss at the next meeting.

Rebecca to prepare PAR revision ahead of the January NPEC meeting.

- iv. <u>Chris Abernathy.</u> Compare the elastomer handbook and the Polymer table in Annex A to determine if any changes are needed. He will report out at the January 2024 meeting.
- 6. Finish review of Annex B

Confirmed that all actions from prior call had been completed and that Annex B initial revie was done. No additional actions on Annex B during this meeting.

7. Review Annex C

Revised the last paragraph of C.1 to refer to the IEEE/IEC 62582 series standards for general condition monitoring techniques and to IEC/IEEE 60780-323 for the use of condition monitoring for equipment qualification purposes.

Revised C.2 subitem e to eliminate the reference to PAOT for EQ equipment and simply state "Confidence in establishing intervals of time between testing that assure continued functionality (as defined by the acceptance criteria) during the entire applicable service life and operating conditions."

Revised C.3 to add a caution that the selection of NDE techniques need to consider not causing other safety hazards. Cross-references to IEEE/IEC 62582-1 and IEEE 1185 were added to the end of the clause, with appropriate bibliographic entries. Also added cross-references to the appropriate IEC 62582 series condition monitoring standard for the appropriate entries in Table C.1.

Action to Tom Koshy to generate a new paragraph about using cable deposits as a means to monitor aging. Koshy's input was received via email immediately after the meeting ended and was inserted into the Rev 0h working draft of the standard on 12/9/23.

8. New Information

George Kyle has been keeping a running list of comments and resolutions for each edit made to P1205 in an Excel spreadsheet. Rebecca will distribute that file with the updated working draft of P1205 ahead of the January 2024 meeting.

Rebecca indicated that NPEC would be voting on a revised P&P at the January meeting and that the WG would need to adjust practices to align with any changes after the new document becomes effective.

9. New Action Item Recap

No new actions, but Chris confirmed his readiness to discuss his last action for the Annex A polymer table at the January meeting.

10. Upcoming Meetings

- a. NPEC meeting with PES in New Orleans, LA January 8-11, 2023. WG 3.4 will meet from 3-5 pm local time on Monday, January 8, 2023. This is a hybrid meeting with both an in-person and a virtual component both of which require a meeting fee be paid.
- b. We will resume regular monthly virtual meetings on February 23, 2024 at 3 pm EST/ 2 pm CST.
