Call to order: 6:30 pm

- 1. Presentation** and adoption of the present Agenda. Moved by Hanli, seconded by Brian, adopted by vote.
- 2. Approval** of 10 Sept 2015 Meeting Minutes, as emailed to ExCom officers. Moved by Brian, seconded by Hani, approved by vote.
- 3. Action Items** Hector noted that his chapter has still not received a rebate this year and is greatly in need of the funds. Since the section received its rebate on Apr 28, 2015, the section is overdue in distributing chapter rebates. **Action: The section will disburse chapter rebates no later than Nov 16, 2015 and will establish a date when the new rebate formula will take effect.**
- 4. Discussion Items** Hector noted vTools has not been working well for meeting notifications. Brian indicated that this known, long-standing problem has been discussed at Region 6 Membership Development meetings and suggested alternate approaches such as use of Constant Contact, Meetup and EventBrite as workarounds until the tools are improved. [On Oct. 19, subsequent to the ExCom meeting, Russell Hunter, OCS webmaster noted to the OCS officers by email that no meetings were posted in vTools online, and asked whether the chapters are adding their meetings in vTools or if he should add the meetings to the web site. The secretary responded that this would be a good thing to do. On Oct 20, Russell made a small change to the URL for calendar import, and when chapters add their meetings in vTools, they will now show up on the front page of the website. He cannot himself add the meetings in vTools since he is no longer in Region 6, but anyone with questions about how to do this can email him (russellh@computer.org) and he will assist them. For the next few months or so he will add any meetings to the web site so we have meetings posted.]

K= [(total # of members attending meetings) + (# of meetings)*\$75 + (#of meetings with more than 25 attendees)*25] A=
 # of attendances of the chapter chair/his delegate to the Section meeting in a year;

S= # of Section meetings in a year. D = Section Chair's discretionary factor for top performing Chapter(s) (up to: +3%, -5%)

IEEE HQ Section Activity bonus: In an effort to encourage activities at the local level, activity bonuses may be awarded as reported by Sep 17, 2015 Peggy Kovacs, IEEE Member & Geographic Activities.

All sections reporting **ten meetings or more, at least five of which must be of a technical nature**, shall receive an additional **US\$200**.

All subsections reporting **ten meetings or more, at least five of which must be of a technical nature**, shall receive an additional **US\$100**.

Joint meetings may be counted toward only one unit's bonus. For example, joint meetings of different chapters and/or affinity groups may not be counted as a meeting for both units.

All chapters or affinity groups reporting **six or more meetings of a technical nature** shall receive an additional **US\$75**.

Activity bonus funds are excluded from the 10% bonus for timely reporting.

All units must qualify for the timely reporting bonus (see #5 above) in order to be eligible for an activity bonus.
