1) Motion to approve the agenda (Witold Kinsner, Rashed Minhaz). Carried.

- 2) Treasurer update.
- -Haider and Leslie have signed off on the letter at the bank, Julian has yet to do so.
- -All previous cheques were canceled and new cheques have been issued.
- -It was recommended that concentrated banking be pursued as soon as possible in the new year. Everything is on line and IEEE Canada is dealt with as if they were the bank. IEEE Canada then contacts the bank so that section personel do not need to hold accounts.
- -Both cheques written to GOLD were from the same account, but different accounting books (GOLD, Section).
- -The reasons for holding all GOLD, WIE, and Seciton funds in one account was for security and ease of management. In the past, separate accounts have had difficulty with accounting for each groups funds.
- -It was noted that the transactions should be visible and transparent as the banking is moved from separate accounts to concentrated banking. The issue needs to be resolved.
- -The bank has been asked to print out the section assets and liabilities.
- -It was proposed that the past treasurer be called to the bank along with the present Chair to determine the status of the accounts.
- 3) Joint chapter of Robotics and Control.

MOTION that the IEEE Winnipeg Section establish a new chapter called Robotics and Control whose constituents are the members of hte following three societies. (Witold Kinsner, Leslie McFarlane). Carried.

- -It was noted that students are involved in local university based activities and that helps engagement of the students within the IEEE Section at large.
- -The mechanical department has engaged students by offering to pay for annual dues of students in the IEEE.
- -There are discussions with Manitoba Hydro on getting involved with various societies within the IEEE.
- -Creation of chapters is an aid in retention of members from student status to full member status and beyond.
- -Students could be encouraged to not just exist in a technical boundary but get a social aspect of IEEE membership.

- 4) University of Manitoba Student Branch report
- -The information will require some follow up.
- a) The Mark Roy and Paul Klassen won the Western Canada Life Members Award for the 2008 IEEE Canada Student Paper Competition and a plaque has been received by Witold Kinsner and is to be awarded at the upcoming AGM with a specific format suggested by IEEE Canada.
- -The student chair will need to be in attendance at the AGM to receive the plaque to be placed at the McNaughton Center at the University of Manitoba.
- b) The 2009 Telus Innovation competion was won by Mark Roy and Paul Klassen on September 18th 2009.
- -The Telus Innovation award was formed 5 years ago and carries a prize of \$10,000 for the sucessful submitted project. 10 teams are selected from all of Canada for a verbal presentation and examination in Mississauga with the award going to the individuals of the winning projects. The projects are varied and not limited to Communications, but typically wireless is involved (but not required to be involved).
- c) Two teams have participated in the IEEE Extreme Programming contest from the University of Manitoba. There were 1000 teams that took part in the competition comprising 3000 students. The teams placed 33rd and 43rd out of 236 teams that submitted solutions to the programming problem (1000 registered), so the teams did very well.
- d) The IEEE Canadian Foundation Scholarship has been awarded to Matthew Sebastian on May 2nd, 2009.
- e) Roberta Bondar was intercepted as the international space station passed over Winnipeg. A number of High School students from across the province were involved to make IEEE known at the secondary school level.
